

Summary: Traffic Engineering Section investigates traffic safety complaints, performs engineering analysis, and mitigates traffic issues in accordance to the County standards and practices.

Background Information:

 Traffic Safety Investigation evaluates the existing roadways and intersections based on traffic requests as well as Collision Surveillance Program. Some of these evaluations include the following:

Parking restrictions

Intersection visibility

School traffic

Speeding

Traffic Signal Warrants

Stop signs

Speed limit certification

CHP accident reports

- The Neighborhood Traffic Management Program (NTMP) is a program that evaluates and designs traffic calming devices to mitigate traffic issues on residential streets. A common traffic calming treatment option is speed bumps. A public process is involved for streets to be considered for NTMP. When designed properly, speed bumps can reduce the overall traffic speed on the street to at or near the posted speed limit.
- Collision Surveillance Program is intended to identify locations with repeated collisions through the use of Crossroad traffic collision database software. Crossroad database is compiled with the Traffic Collision Report provided by the California Highway Patrol in the unincorporated part of Sacramento County. When a certain number of traffic collisions occurred in one location or a segment of roadway, an investigation is conducted to determine the possible causes and may followed by recommendations for traffic safety improvements. The program also provides data to support County CIP projects and Grant funding programs. Staff also reviews collisions which result in damage to County property. These reports allow staff to send invoice to insurance company for reimbursement of repair costs.

Summary: This project will construct bicycle lanes to connect to the existing bicycle lane network on each side of the project creating an east-west facility 6+ miles long with traffic signal improvements to provide accessibility for pedestrians and bicycles.

Funding Source(s): Active Transportation Program (ATP) – Construction, Community Development Block Grant (CDBG) – Pre-Construction, Measure A

Background Information:

47th Avenue serves as a major transportation corridor for all modes, however, complete facilities currently exist for vehicles only. The project corridor is over 2 miles long with a light rail station at one end, a freeway interchange in the middle, major housing developments throughout, and commercial corridors on the western and eastern end of the project segment. Pedestrians must currently navigate sidewalk gaps, high-speed on/off freeway ramps, inaccessible intersection ramps, and high speed vehicular traffic and bicycle lanes are non-existent.

This project proposes to fill in gaps where sidewalks are missing and/or widen the roadway to construct continuous Class II bicycle and pedestrian facilities in the corridor so that all modes have a space, can easily navigate, and thereby increase active mode usage. Traffic signal modifications will also be made to accommodate the changes for bicycles and pedestrians, and many of the bicycle lanes will be buffered to provide additional separation from vehicles where possible.

The environmental process is complete, real estate acquisition is underway, and construction currently anticipated for 2020.
