



Update: The proposed South Watt Avenue Improvement Project was brought to the Sacramento County Bicycle Advisory Committee (SacBAC) with the preliminary design on September 9, 2020. After the presentation to the SacBAC, the Sacramento County Department of Transportation (SacDOT) applied for and received a grant to provide a Class 1 multi-use path. The interim project will now have 4 vehicle lanes and both an off-street and on-street buffered bicycle lane, as shown in the roadway cross section below. In the future, when South Watt Avenue is widened to 6 lanes, the off-street bicycle facility will be removed and the Class 1 shared multi-use path will remain.

Proposed 4-lane roadway cross section:

The bicycle facility will ramp down at the signalized intersections and the bicycles will join traffic at the standard locations in the intersection. The attached striping exhibit (Attachment 1) shows the bicycle ramps at Jackson Road (SR-16), Fruitridge Road, Elder Creek Road, Wayne Court, and Florin Road.

Funding Source(s): Florin-Vineyard Community Plan Public Facilities Financing Plan, SACOG Regional Funding Program, State Transportation Improvement Program – Regional Improvement Program (STIP-RIP), County Measure A Sales Tax, Sacramento County Transportation Development Fee Program (SCTDF).

Total Project Cost: \$42,000,000

Background Information: The proposed project is located on South Watt Avenue, between Jackson Road (State Route 16) and Florin Road, as shown in the attached Vicinity Map (Attachment 2). The project will widen South Watt Avenue from two to four lanes and construct complete street improvements such as landscaped medians and turn lanes; install enhanced pedestrian connections including curb ramps; modify existing intersections and traffic signals; rehabilitate and resurface pavement. Prior to receiving the grant, the project only included the installation of buffered Class II bike lanes. The project will provide increased capacity, improved performance, increased multimodal travel options, long-term economic benefits, improved goods movement, improved safety, regional congestion reduction and maintain the corridor in a state of good repair. The entire project is approximately 3.2 miles in length.


South Watt Avenue is a primary transportation corridor serving southern Sacramento County and the cities of Sacramento and Elk Grove. It is a major access route between these areas, State Route 50 (SR 50) and the balance of the Watt Avenue corridor to the north, which is one of the region's most heavily traveled routes. South Watt Avenue supports circulation within and between South Sacramento communities, serves as a major route for commuters, and provides access to key regional transit facilities including the Sacramento Regional Transit District (SacRT) Watt/Manlove Light Rail Station. South Watt Avenue also supports major industrial and commercial distribution centers in the Florin-Perkins area, including the Florin/Fruitridge Industrial Park adjacent to the corridor, and the Packard Bell and Depot Park facilities to the west. It provides a goods movement connections to the larger national and regional truck route network including US 50, SR 99, I-5 and I-80. The south Sacramento County region, including the Florin/Vineyard Communities and the City of Elk Grove, is experiencing substantial growth and will continue to rely heavily on the South Watt Avenue Corridor to sustain its economic viability.

South Watt Avenue between Florin Road and Jackson Road is currently an outdated rural-type roadway with one traffic lane in each direction and no accommodations for transit, bicycles and pedestrians. The roadway has an average daily traffic volume of 29,000 vehicles and a volume to capacity ratio of 1.6. This results in heavy congestion and level of service (LOS) F conditions throughout the corridor and on intersecting and parallel arterial roadways for extended periods particularly during morning and evening peak hours. Current deficiencies in roadway capacity also increase travel time for commuters and impact the efficiency of commercial operations and goods movement within the corridor. The existing roadway configuration and congestion levels also impact safety for all modes of travel, due to higher incidences of unsafe passing and the lack of accommodations for safe turning movements into adjacent businesses




and residential areas. The project segment of South Watt Avenue also lacks transit, pedestrian and bicycle facilities which discourages walking and cycling, and limits travel opportunities.

The preliminary engineering as well as the environmental review and clearance process is underway. Construction is scheduled for 2023, pending funding and right-of-way acquisition.



Item 4 - Attachment 2 – South Watt Vicinity Map







Summary:

SacDOT Traffic Engineering staff reviewed the City of Sacramento's Slow Streets program in order to learn more about feasibility of the program for unincorporated County. The program used a self-nomination form available on the City's website in order to identify pilot locations. Staff spoke with Jennifer Donlon Wyant, the City's Transportation Planning Manager, about her experience in managing the program.

According to Donlon-Wyant, the City's program took much more staff time and equipment (i.e. signs) than was anticipated. Residents adjacent to the pilot area complained about increased traffic on their streets. Some residents within the pilot area complained due to a perception of more trash on their street due to the Slow Streets program. While there is use of the Slow Streets program, it did not appear to yield an increase in biking and walking.

SacDOT staff performed counts on three of the City's pilot streets in order to learn more about the pilot program's effectiveness. Counts were taken on one day during April 5-7, 2021 from 4:30 p.m.-5:30 p.m. at three pilot street locations in the City of Sacramento: 26th St. from P St. to Q St.; O St. from 22nd St. to 23rd St.; and V St. from 22nd St. to 23rd St. Few bicycles and pedestrians were recorded on street in the pilot locations during the count periods. Pedestrians were generally using the sidewalks. See count data attached.

The initial data and City's experience suggest a lack of change in walking and cycling traffic as well as high cost in staff time and equipment. City of Sacramento recently implemented new streets in the Meadowview area in South Sacramento. Staff will be gathering additional data to learn more about this program.





The County of Sacramento sponsored 50 Corridor for May Is Bike Month 2020.

Activities:

These gift cards were sent to randomly selected trip loggers every Friday. For small businesses that did not have gift cards, the 50 TMA designed and distributed digital gift cards via e-mail.
- Made instructional videos for how to log your trips on MIBM.com, fit your helmet, and bring your bike on local transit.
- Hosted a Zoom bicycle center
- Hosted Zoom bike themed picture book read-alongs for kids
- Launched a Social Media challenge to engage a wider audience

Results: According to SACOG, the region experienced an approximate 65% drop in participation from prior years. The 50 TMA experienced about a 50% drop in participation, however, the 341 participants surpassed their pledges in both miles and trips:

Bicycle Education Programs

- The County of Sacramento sponsored Sacramento TMA for May Is Bike Month 2020.
- The Sacramento TMA expanded the spring bicycle crusade through the fall, offering support at three levels: people that needed to bike, individuals previously bicycling, and employers.
- The TMA encouraged people to try their bicycle commute route while the streets were quiet, particularly downtown where the last half mile to the working environment can be the most confusing and worrisome.
- The Sacramento TMA gave \$2,100 in gift cards to people who logged bicycle trips on <u>sacregion511.org</u> May through October.
- The TMA additionally gave gift vouchers to individuals who bicycled for the first time. TMA staff, every avid bicyclist, worked with people who wanted to try bicycling, offering individual assistance by email and instruction by Zoom classes on skills and tips about riding on the street, putting their bicycle on a bus and picking the best route.
- The Sacramento TMA supported employers by giving them email messages of encouragement to send to employees.
- The TMA sent Commute Coordinators a spreadsheet of individuals from their organization that participated in May is Bike Month 2020 so they could track progress toward their goal of exceeding 2019 participation.
- The Sacramento TMA sent 9,023 emails out to individual people regarding information about bicycling and how to register for and participate in the bike month campaign.
