SUBJECT: Estimated SCTDF and TIF Fee Reduction due to Overlaps with Adopted Financing Plans

Sacramento County has existing and planned "special financing districts" to fund major infrastructure within or near those districts, including transportation improvements. Many of the roadway and intersection capacity improvements and some regional trails and transit improvements that are funded by the special financing districts are also included in the 2018 Sacramento County Transportation Development Fee (SCTDF) Program Update. The SCTDF and Transit Impact Fee (TIF) cost responsibility for development that is subject to each special financing district will be reduced by the amount that is funded by that district to eliminate any overlap between the fee programs. Thus development within all special financing districts will only pay their "fair share" of any improvement identified in the 2018 SCTDF Update.

This memorandum documents the estimated funding overlap and corresponding reduction in SCTDF fee and TIF rates for the following four adopted public facility financing plans:

- North Vineyard Station (2005)
- Vineyard (2006)
- Antelope (2018)
- Mather (2002)

Some of the four existing finance plans and other planned finance districts are anticipated to be updated or adopted either in 2019 or the following few years. The reduction in SCTDF and TIF fee rates to account for any funding overlaps will be determined at the time when a special finance district is updated or adopted.

Summary of Overlapping Funding and Fee Credits

Table 1 summarizes the funding overlaps and fee credits for the four adopted financing plans listed above, including all updates to those financing plans through March 2019. The SCTDF and TIF fee rates that will be presented to the Sacramento County Board of Supervisors for adoption on April 9, 2019 reflect the reduced "DUE Fees" shown in this table. The costs and fees rates in the February 2019 SCTDF Nexus Study were based on 2017 cost data. The SCTDF and TIF fees rates in the Nexus Study were adjusted for inflation based on the change in Caltrans Construction Index between December 31, 2017 and December 31, 2018, which was an increase of 6.4%

The estimated cost of overlapping roadways, trails and transit projects for each of the four adopted financing plans shown in Table 1 are documented in the following section.

Estimated Cost of Funding Overlaps

Overlapping Funding for Roadway and Transit Improvements

Tables 2 and 3 are lists the SCTDF roadway and intersection improvements that have overlapping funding in adopted financing plans.

Sacramento County Special Districts has estimated the cost of the overlapping roadways and transit projects in the North Vineyard Station and Vineyard financing plans, which are documented in Appendix A and Appendix B of this memorandum respectively. The costs in those financing plans were adjusted to reflect 2018 costs based on the escalation since the time those financing plans were adopted. The North Vineyard Station financing plan has some transit improvements that overlap with the TIF while the Vineyard financing plan does not.

DKS identified the roadway projects in the Antelope and Mather financing plans that overlap with the 2018 SCTDF Update. Appendices C and D of this memorandum show the estimated cost of those overlapping roadway projects. The total overlapping roadway costs were increased in **Table 1** to account for the March 2019 inflation adjustments for each of these two financing plans. These two financing plan do not have transit improvements that overlap with the TIF.

Overlapping Funding for Regional Trails

Sacramento County Special Districts has estimated the mileage of regional trails in the North Vineyard Station and Vineyard financing plans, which are also included in the 2018 SCTDF Update. The financing plans for Mather and Antelope do not include funding for regional trails.

Table 4 shows the estimated cost of overlapping trails in the adopted financing plans. The cost per mile of trail used in the February 2019 Nexus Study was based on 2017 unit costs. To be consistent with the fee rates that will be to the Sacramento County Board of Supervisors for adoption on April 9, 2019, the trail costs were adjusted for inflation based on the change in Caltrans Construction Index between December 31, 2017 and December 31, 2018, which was an increase of 6.4%.
